Direction: Lord Tirumala Sri Venkateswara decided to arrange his “HARINAAMA KSHETRA” near our “Gardenwell” in my native village Chinna Gundavelli, 7 km. away from Sidhipet. He directed me to construct at least the replica of Tirumala Temple upto two compound walls (Silver Doors). He assured me that He will stay here permanently forever in this area by himself and bless the devotees. Also He suggested to arrange Akhanda Harinam Smaran (chanting) by various devotees in shift system with no break. He also informed me to get blessed by Bhagavataas (great devotees) in order to get eligibility to invite Lord from Tirumala besides rigorous practice (Sadhana).

Starting the training from April 2000, thro’ my dreams, He disclosed the actual matter in April 2022. In addition to this, He ordered me to get

the divine feelings published which were blessed by him in order to make the devotees as partners in this programme from April 2023. The publishing of present part-15 its part only (February 2005 – April - 2005).

The Divine Act shown by Lord in construction of my House

The construction of my house was going on in Kakatiyanagar, Habsiguda, Hyderabad. It was 15.02.2005, i.e. Dasami. Thinking that It was an auspicious day, we arranged the main door frame of the house. On this door frame, we arranged both Conch and Disk (Sankh and Chakra) on either side of auspicious mark (Thirunaamam) in Lotus in the middle of this door frame.

At the time of adoring and keeping it vertically, I witnessed just only the Lotus feet of Sree Venkateswara. I felt that every flower, I offered was falling on his feet. I prayed him with a request to stay in my home along with me and I have worshiped to my utmost satisfaction. But to my wife, Lord appeared as an old person with auspicious marks (Bottu) on forehead exactly like an aged person in the same dress which was exactly wore by that old man who went to Rukmini. Her Joy knew no bounds. Tears rolled on her cheeks.

It means Lord blessed her by himself. It also means that Lord himself, blessed us with this house and showing us all these divine acts likewise as we viewed the divine acts of Lord in every moment of the construction of our house.

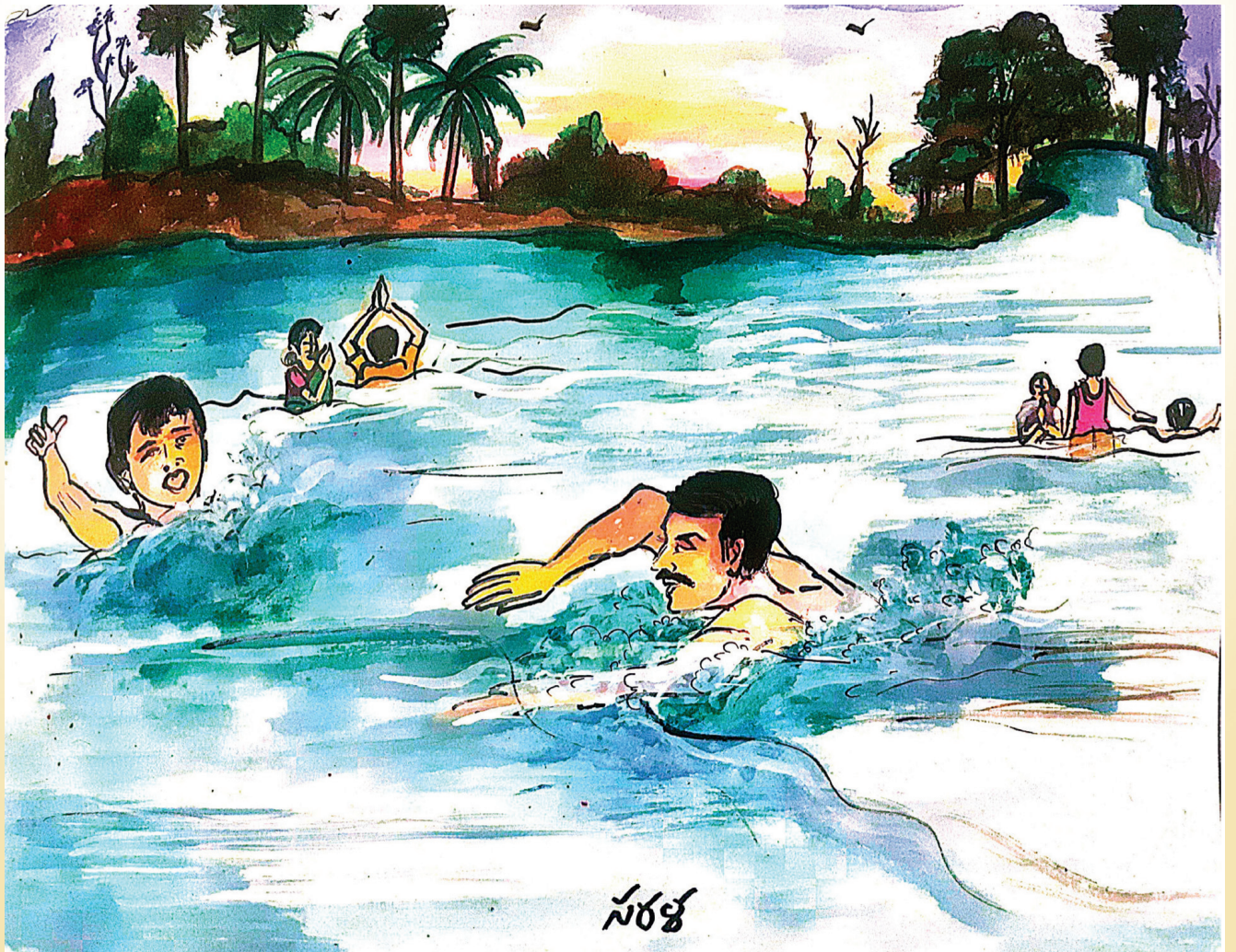
Land issue: The disputes of my Miyapur property reached peak inspite of my heartfelt prayer to protect me. But it turned futile. In other words, It was of no use. Every turning in these disputes took place as directed by Lord who ordered me to go ahead with no fear and doubt. I witnessed a dream stating this same point:

The dream on 26.02.2005:

I witnessed two different incidents in this dream. I was twenty years old in the first one. At that time, we

were in cultivation near Garden well in our village. That day, I too went to our field and observed our gardens; but the workers all were sitting in a room and chitchatting without attending the work entrusted to them. Later, I went to Agriculture field of Late Pullagurla Umma Reddy, my father's elder brother. He said to me to take workers if required (He expired in 1993). That's all. I couldn't follow the dream. Probably it might be a warning to me since I was not making efforts to acquire the Land for Harinama Kshetra. So it may be more delayed or It also might be that only my capacity is insufficient. So the capacity and co-operation of my elders are need to be taken.

In second one, I had been to a river to take a holy dip. I found many devotees were taking bath.





I got down in the river, went to a place where less water was there and started swimming towards the place where more water was there. Meanwhile a wave approached me, but I didn't care and moved ahead. Afterwards, I was returning back. Suddenly, at one place I stopped with a suspicion that it might be deep there. Then, I found my second son, Chi. Arvind Reddy, aged about 12 years stood there and called me, "Daddy! Here the water is less. Not at all deep. At that time the level of water was below his chin. On seeing him, I stood up with no fear. The water was in Milk colour. That's all. My dream got disturbed.

INTIMATED ME THAT SOME GREAT PERSONS WILL VISIT MY HOME

About Home: Lord of Tirumala Sree venkateswara blesses me with his Divine Acts every minute according to my mental condition. He used to create some Divine Acts in an encouraging way and some predicting the future. He encouraged me showing the below divine act that some Renowned and Respected persons visit our function of "Gruha Pravesham" [Entering (opening) ceremony of New House].

I, at the time of completion of my Engineering studies, met Sriman Nara Chandrababu Naidu garu probably with an intention to become a leader; but Later as I, didn't like that field, I have chosen the business field. Lord has chosen this incident now.

Dream on 13.03.2005:

I, in the dream, was in New a House entering function. Then our Ex-CM (Now present (CM-AP) came alone driving his Maruthi 800 car by himself. He called me by name and said "you came to me you know! I remember your name". I told him about offering of 7 crore Japa offering as 3rd time. I gave a few Japa books to him. Meanwhile, He talked about some other issues. In the middle I have drawn his attention on this point again. After some, time He vanished, and my dream.

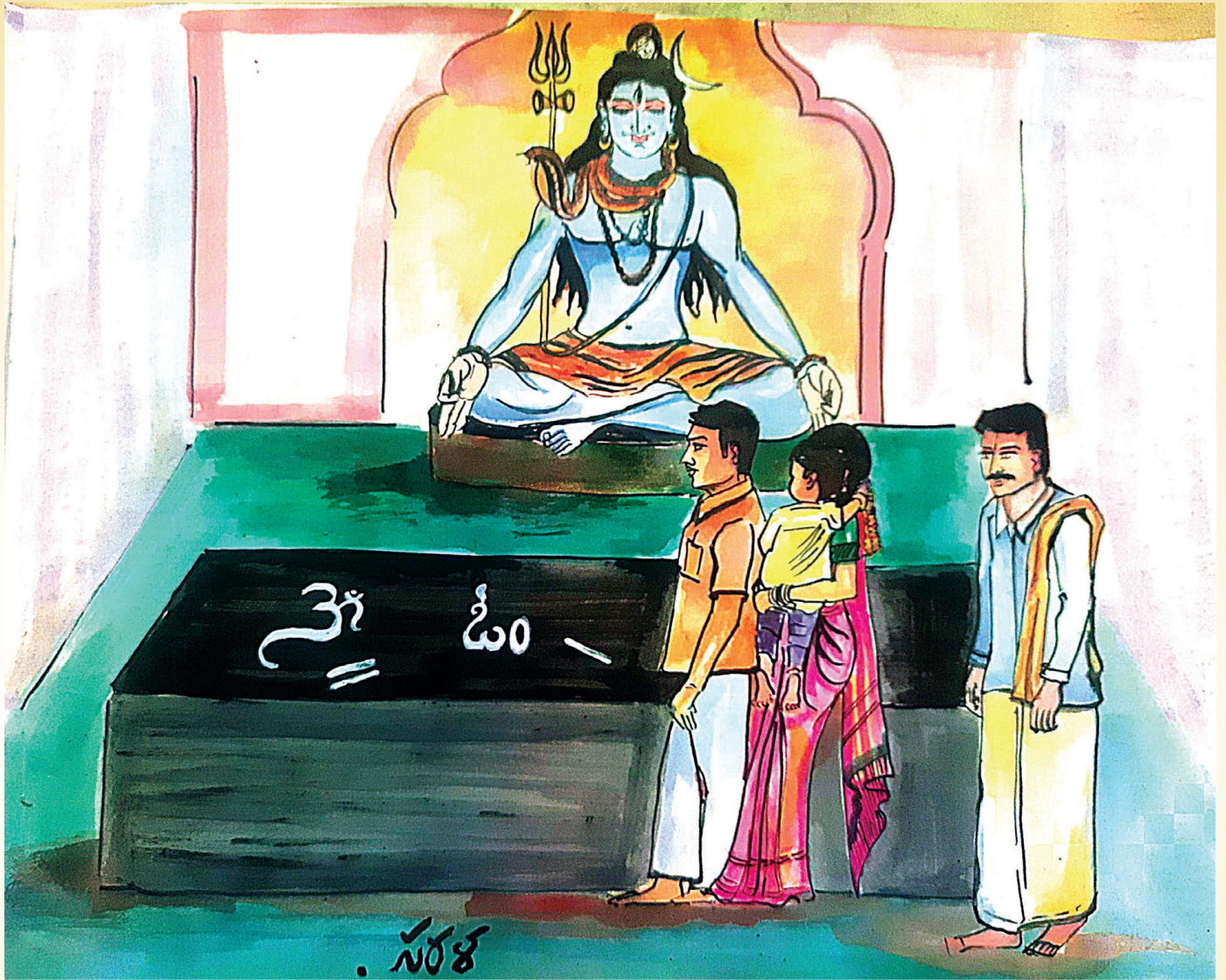
It means, some noted persons will come to my Gruha Pravesham (Entering Function of a New House) and it looks as if it is the function of Lord. He, in another way, indicated that I am unable to forget the idea of serving Lord even in personal functions like entering function of New Home (Gruha Pravesham).

ORDERING TO START (TO RUN) THE MAGAZINE NAMO VENKATESAAYA

About Magazine: Lord Sree venkateswara directed me to run a monthly magazine in the year 2003. At that time, we were busy in making "NAMO VENKATESAAYA" Chariot. So, I planned to start it in the year 2005. Though I have no idea about the procedure of running a Magazine, thinking that Lord only will guide me, I got permitted, a title – "NAMOVENKATESAAYA" and was ready to do so. I submitted the declaration also. One who assured to help me to run the magazine escaped silently. In fact, I was ready, to run the magazine from January 2005 after getting all permissions. Also I had neither Articles, nor list of Writers with me. Three months rolled away in this confusing state. Totally 16 months passed away after Lord ordered me. I felt bad. I was very much particular to start the magazine. Though it was the order to Lord, but no idea how to start it. Moreover, I thought that, Swami told me to start it by hook or crook.

I have consulted many persons who published the magazines earlier. They discouraged me saying that these spiritual magazines have no market and after six months they will have to be stopped. I was told that it needs more courage and money to run a magazine. I started thinking deeply. I was in confusion. Finally I informed to my wife Surekha on 04.03.2005.

Surekha said "okay. We will run it but not now. We, after completing 60 years of age and discharging all responsibilities can do it"; but I said if it so, why Lord Sree venkateswara ordered me to do it now. Then after thinking a while, she said – "Then we, next year



or after opening ceremony of house or during the period of Third Japa dedication. (i.e. in September 2005) publish it.

I started thinking very deeply after hearing to my wife Surekha. As a matter of fact, God himself told to start this. So.... Instead of discussing about when this should be started, I thought, better to leave this to God only. Afterwards we left this subject to Lord Sree Venkateswara. In other words, we decided to start this on the date as decided by God. As the “ball now is in the court of God”, I got relief from the worry that we did not obey his word. I was so delighted. Accordingly, I prayed Lord to tell us the starting day.

On 11.03.2005, at 10-30 AM as I was busy in the Registration Programme of a house constructed by me, it was cancelled, unexpectedly when I was on the way to my home. So, I got some leisure time. Then I visited the temple of Sri Anjaneyaswami and prayed Hanuman and Lord Shiva also whose temple was behind Hanuman’s temple.

I prayed Lord Sree venkateswara “O” Lord! Venkateswara! You asked me to start a magazine “NAMOVENKATESAAYA”; but you did not inform the date when it is to be started. Please inform me. I never expected that Lord Sree Venkateswara will reply me so soon; But on the same day, during night time, He



indicted as under and showing me a wonderful divine act and asked me to start immediately.

Dream on 12.03.2005:

I viewed this dream in between 5 am to 5.30 am in wee hours. It was a big hall in which I saw an inner temple in square form. There I saw Lord Shiva's idol of 4 in Meditation posture. There was a very long platform like kitchen platform with black stone.

It was like a very big pad on which devotees can keep paper and write something, looking at Lord I was told that it was a special hall exclusively for celebrating "Aksharabhyaasam" function (Beginning of writing / reading function of a kid) I entered the temple in Traditional dress code as fixed in Tirumala Temple (Dhoti & Kanduva). That 'path' was resembling the way of Tirumala Temple with marble flooring and one side Jalee (fencing). I had the same feeling as if I am going to have a darshan of Lord Tirumala Sree Venkateswara only. A couple with a baby, aged about 3-4 years, was also in the Que for celebrating time function of baby before Lord. Of course, I too was going for same purpose i.e. Aksharaabhyaasam. Though they didn't tell me that they are going for celebrating Aksharabhyaasam, but these feelings were very clear in my mind. That's all, my dream got disturbed. I woke up.

I have analyzed the dream next day. I thought that Lord Sree Venkateswara has ordered me to start the monthly Magazine (periodical) immediately, but I was perplexed since I didn't possess the Articles or List of the Names of writers. I was in diellama how to proceed. Later, I started procuring these all.

PROCUREMENT OF WRITERS' LIST

TTD has commenced Mahaa Laghudarshan for the first time since there were continuous holidays like Holi and others from 11 to 13th March in 2005. Nearly 70,000 devotees had darshan of Lord in one day. It

was published in Newspapers. But, the crowd was less in Tirupathi. One day night, I felt as if Lord himself invited to bless me with his darshan to my utmost satisfaction. One way, I suspected whether to believe this Divine Act or not to. Later this, feeling turned into reality as under:

One, Late Sri Venkata Sharma working in TTD Dharma Prachara Parishad, he used to move closely with Executive Committee. I know him. He was a great devotee. When I was in search of writers, I remembered him, immediately I contacted him on 22.03.2005 and said – "I would like to start a monthly periodical "NAMO VENKATESAAYA"; but I do not know any writer and no idea about the items to be included in it. So please help me". Unfortunately He too expressed his inability in this regard He told me that "TTD will conduct a National Seminar on 30 & 31st March in Tirupathi on the Topic "Sri Venkateswara Vaibhavam". Many eminent personalities including writers, poets and intellectuals will attend from all over India. So better if you attend this seminar to get proper guidance. Also He arranged an Invitation card on my name i.e. P.Sai Reddy, Sri Venkateswara Mahaa Mantra Peetham, Hyderabad which I received on 24.03.2005.

This invitation created duel feelings in me. In other words, one way, I was glad and another way I was sad. I don't know anything about Lord Sri Venkateswara and I have no communication skills. As such, what I can say in that seminar about Sri Venkateswara? Finally, I convinced myself that I am attending the seminar just to collect the addresses of writers but not to address the gathering to or speak about the glory of Lord Sri Venkateswara. But for safer side, I made Late Sri Varanasi Venkateswara Sastry to write about the glory of Lord, prepared well and was ready to attend the seminar.

As decided, I attended the National Seminar about Sri Venkateswara Vaibhavam (The Glory) held

at Tirupathi on 30.03.2005. I had a chance to see and meet many great personalities there. I heard about a number of subjects and discussions about Lord Sri Venkateswara in that seminar. It was for the first time to me to hear so many points and narrations about Sri Venkateswara. Sometimes I used to get shaken. Those two days were rolled away like two minutes without my knowledge. I collected the addresses of some scholars whom I met there. Also I received the Articles submitted by Authors in that seminar. Thus, this seminar helped me a lot.

Later, I went to 'Sapthagiri' office and contacted Later Sri Rama Murthy who gave me some more addresses of writers. Also He gave me a good advice how to run a magazine along with a suggestion to run it for many years.

The TTD has arranged Darshan facility to all who attended National seminar on 31.03.2005. Unfortunately, I lost this chance since I was hunting writers. Finally somehow, I got the opportunity at 7.30 pm on cellar ticket and had darshan of Lord. To my surprise, no one pushed me at the time of Darshan of Lord. There was no rush. I stood for nearly 10 mts there and gazed at Lord from top to toe very keenly. I was delighted very much. I felt as if I was there invisibly earlier also. Next day morning the Temple staff etc. were cleaning the temple giving holy bath on Friday. I joined TTD staff and washed the temple. Meanwhile one person identified me and said Outsiders are not allowed for this service. So, I was sent out. Next day also, I had darshan in morning hours. The number of pilgrims was very less. On Rs.50 Tickets, I had quick Darshan within no time.

Therefore, as per my feeling on 20.03.2005 during night time, I got an invitation and had divine darshan as he blessed me. There were pilgrims in less number. On the other hand, I procured the addresses of writers pertaining to Magazine.

SATISFYING SUREKHA

Lord Sri Venkateswara has shown me one more Divine Act. He blessed my wife Surekha and made her to see this. This divine act was as under:

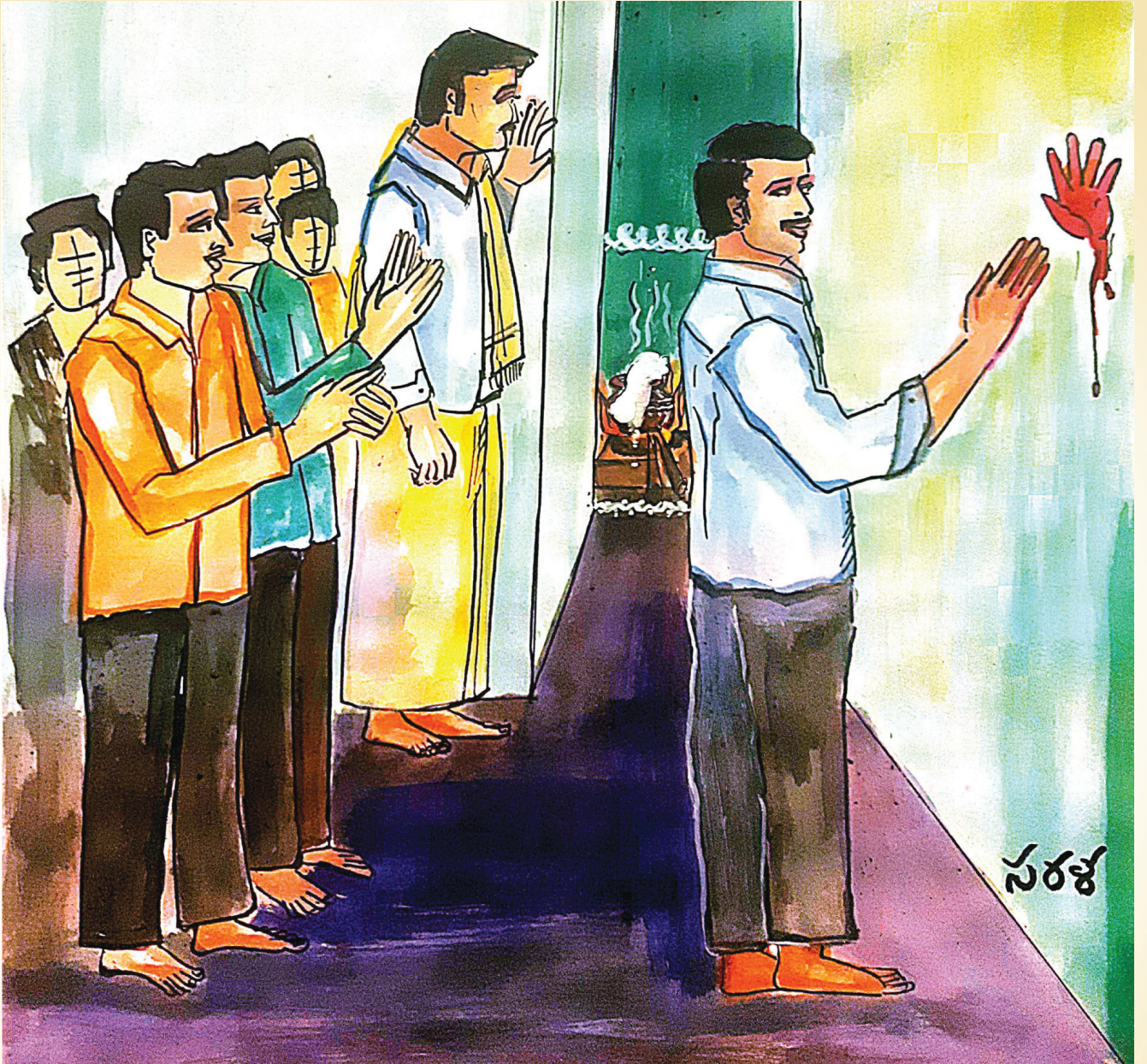
She used to adore in Pooja (worship) room only in my absence. Today i.e. on 01.04.2005 at 6.30 am, when she was adoring Lord, she saw a wonderful scene. She saw the temple of Lord Sri Venkateswara in my flat in Hyderabad. Also she saw me in the temple while I was returning after Darshan crossing the two giant bells. I was in Traditional dress at that time. She was taken aback after seeing this wonder. I too came out from the temple in that dress after Darshan at the same time approximately. Thus Lord, satisfied Surekha by showing such an incredible Divine Act.

CONVEYED BEST WISHES ON THE OCCASION OF RELEASING MAGAZINE

I returned from National Seminar to Hyderabad on 02.04.2005. I dreamt a dream on the same day night as under:

Date 02.04.2005: I was in Traditional Pooja dress in Sri Venkateswara Dairy form. There were many Devotees and employees along with me. Meanwhile New EO. TTD Sri Sharma and Sriman Harinath Reddy, Dairy superintendent also visited. All the Devotees and Employees started hiding on seeing him due to respect. I approached EO and requested him to inaugurate some or other time. As a part of that inaugural function, I requested him to hit the wall. Accordingly, He hit the wall with his palm after keeping his hand in Kumkum mixed water. The devotees, on seeing this, clapped for long time. Meanwhile, I went to the other end of that wall and peeped into it. To my surprise, I found a small ditch where a small pot, filled with boiled milk. It was alike Sankranthi boiled milk. That milk got boiled towards me. There ended the dream.

Probably Lord conveyed his best wishes for my magazine NAMO VENKATESAAYA and asked



to start it. Also He informed me that the Magazine will run properly but I couldn't understand this.

WRITING LETTERS TO WRITERS

Later, I wrote a letter to every writer requesting him / her to co-operate me to run the Magazine. I requested them all to send their valuable Articles to my Magazine which is being run under the aegis of Sri Venkateswara Mahaa Mantra Peetham in order to enable the devotees to know the glory of Lord Sri Venkateswara and increase more the Spirituality in them.

I also welcomed their valuable opinion about the Magazine. In response to this, many writers sent their Articles. Some of them have appreciated my programme and some expressed their happiness that they were glad to see the Name itself i.e., NAMO VENKATESAAYA and felt as if they have received my letter directly from Lord only. Somehow, I procured 30-35 Articles. Later Sriman KV Raghavacharyulu, Tirupathi has encouraged me a lot. He suggested me to go ahead with confidence just thinking that you have received order directly from Lord Sri Venkateswara.

In a nutshell, every one patted me in their own way different from each others.

GIVING UP THE IDEA OF MAGAZINE

Though I carefully arranged all the Articles in a file, but I again became the victim of confusion i.e., what to do and How to do. I suspected myself whether can I run the Magazine. I collected opinions of some known persons who suggested me to not to take up since it is a risk. I thought these articles are well enough for one or two months and what to be done later. I may loose my prestige if I stop the Magazine in the middle. Even my better half Surekha advised me not run it as it is beyond our capacity. Some more well wishers asked me to continue my Japa Dedication programme and give up this idea. Finally I too decided not to take up the task of running a magazine but thought to assist those who come forward to run it wholeheartedly. In due course, I totally forgot about the Magazine. I engaged myself in procuring some more properties; but later, I was taught a lesson by Lord of Tirumala Hills and faced bitter experience.

Infact, I never thought of running a magazine of Sree Venkateswara in my life. Even I don't have capacity or eligibility also to run it; But Lord Sree Venkateswara took more pains to convince me to run the magazine compared to all services he blessed me till date. In other words, I troubled him a lot in this regard. I thought I may not get time and also face problems financially; But, at the end, He removed all the hurdles one by one and made me to start the magazine with pleasure. We know about this later.

The moment when I was blessed by Sree Venkateswara i.e. from the year 2000, I severed my connections with all earthly matters one by one. I reached a stage where I used to feel that Lord Sree Venkateswara only is my Company, my Power and everything to me. To be in frank, I am in this position because of the power provided by Lord. My condition at present is so pitiable

that I am unable survive continuously even for 10 days without seeing 'HIS' Divine Acts. Since He is blessing, taking it granted, I had a desire of witnessing his Divine Acts more and more. I never left even a small item useful to witness Lord Sree Venkateswara. A few of them are as under:

1. I had a desire to have a Darshan of view Lord after constructing the Sree Venkateswara Divine Mahamantra Sthupam on 21.09.2002 at Tirupathi. I prayed - 'O' Lord! Please give me your Darshan if you really accepted this Sthupam (Pillar)". Accordingly Lord Sree Venkateswara blessed me. I was more delighted. I witnessed Lord as I have seen him in the moment gifted to me on day of the inaugural function of STHUPA organized at Tirupathi by Sri Sri Sri Jayendra Saraswathi Swamiji.

2. I offered first 7 crores of Japa Kratu on 14.06.2003. A desire appeared in my mind. Then I prayed - "O Lord! Show me your golden feet if you accept this. Accordingly, on Tholi (Firsti) Ekasadasi, God made me to lie down on a sleeping Swing and made it to swing and shown his golden feet. I was so much happy, My Joy at that time was inexplicable.

3. After second 'Japa' offering on 07.9.2004, I requested Lord Sree Venkateswara to show my late father and he accepted this. Then He has shown me my Father. At that time also I was so much delighted.

Like this, I used to serve and expect the blessings of Lord Sree Venkateswara. Infact, it was only a powerful tonic for me to give necessary strength. I desired only his "Mercy" but not else. I never cared the appreciations of Devotees. In this process, we prepared the Chariot of 'Namo Venkatesaaya' and started at Tirupathi on 11.08.2004. Everyone including EO appreciated it. During the second Japa offering, we travelled from Hyderabad to Tirupathi by chariot and provided the blessings of Lord to some thousands



of devotees. We completed the chariot and used it efficiently once in service of Lord Sree Venkateswara.

Since, I worked hard in making the Chariot and arranging Radhayatra (chariot procession), I thought of getting proper remuneration from Lord. I prayed him to give his darshan to me if he accepts this chariot and agree to take Japa offering after 07.09.2004; But, unfortunately Lord didn't accept this inspite of my repeated prayers. Earlier to this 'He' used to accept immediately but not this time. At one point I lost my temper, failed to understand what to do. On one occasion, I approached Sri Sri Sri Ramachandra Jeeyar and explained my agony to him. I complained that neither my property disputes are solved nor my Chariot is accepted by Lord. Then He convinced said to me to wait and see Don't be hasty. It will take little more time". But so far seven months were rolled away. Swami (Lord) didn't bless me. In other words, I didn't get his reach on till 25.04.2005. I, as Jeeyar Swamiji said, was just waiting and waiting.

Land issue:

Today, i.e. on 25.04.2005, there was a meeting with those hooligans with regard to my Land dispute. They taking my weakness as granted, demanded more land. Finally they said, "Give us if you are willing or else we can buy even Justice also in court. No court can prevent us". One way, I guessed that they along with court, might have consulted police also in this regard and convinced them in their favour. I returned pitifully and whole heartedly. "O Lord? What is this? How it is happening? I kept my Land issue near your feet, with total faith that you will protect my property but invain. Those Goondas and Anti-social elements filed a case against me only. I am loosing my trust on you and your Divine Acts. You are not taking seriously my prayer. It is pinching me a lot. On one hand, you are not saving my property and on the other hand, you

are not accepting my chariot "Namo Venkateswaaya". How long I have to suffer like this?". The tears rolled down on my cheeks. I prayed Lord in many ways. Finally, I left for home with heavy heart.

"THE DREAMS ARE TRUE ONLY I WILL PRODUCE THE EVIDENCES" - Sri Lord Venkateswara

Another important Point:

My faith on Lord started decreasing day by day since my land dispute is not settled. On the other hand, I suspected my self – "why I only am experiencing such Divine Acts and Dreams? Are they believable?" Since Lord Sree Venkateswara smelled my inner feeling, in order to show the evidences that the dreams are true, a feeling started crop up in my mind. "Lord Sree Venkateswara will touch me and that part touched by him gives me a new and different experience than other parts of my body of which were untouched by him. "That's all, it was evidence. Such feelings used to appear in my mind but because of my the then mental condition, I didn't take it seriously. I didn't care them also.

It was a wonderful Divine Act. I was blessed with an unique blessing which reached the peak. He blessed me in such a way that the previous blessings were much inferior to this blessing (Anugraha) though they were all added together. In other words, the present blessing is unique and is of its own kind. With this, my life became purposeful. In the first part of this, Lord had shown me different Forms just to accept the chariot Namo Venkatesaaya. On account of this, I thought that, I am only very fortunate person next to Arjuna, the middle one of Pandavaas.

The second part of this Dream was very long and related to my business. In this, 'He' saved me as he saved 'Draupadi' the wife of Paandavaas previously. I, in my dream itself thought that, I am only the fortunate person next to Draupadi. Lord had touched me in the

same dream to say that all his Divine Acts are true. He lifted my total weight with his thumb. Afterwards, the “part of my body was touched by him turned as a different one from other parts of body. Since that day, I thought that I have to trust those Divine Acts of Lord, which are nothing but true and I should not suspect them. Even the paper on which this divine experience was written also got drenched in rainwater in 2009; But as I kept this ready much earlier in 2009 at the time of publishing “Order of Srinivasa to Publish Sri Venkatesham” after getting it DTP, I am now able to depict you vividly. Let us see this Divine Act in next issue.

MY CONDITION:

Lord has blessed me during construction of my Home in many ways. He asked me to go ahead without getting afraid of Land problems. He directed me to start publishing work of “Namo Venkatesaaya also”. He took

me to Tirupathi and blessed me with his Divine Darshan. Later He made me to collect all the addresses of Writers and ordered to run the Magazine. I am just waiting with thousand eyes, (eagerly) both “chariot” and “Namo Venkatesaaya” also will be accepted as he accepted ‘STHUPA’ (A Divine pillar which was filled in with the books of Mahaamantra i.e. Divine Name of God) and first Japa offering.

BLESSINGS OF BHAGAVATAS:

We are publishing these Divine Acts as decided and directed by Lord just only for taking your blessings and to make you also as our Partners at least in the form of blessings. Therefore, I appeal every devotee whoever goes through these Divine Acts, to pray Lord by forgetting their differences of Age, Caste, Colour, Sex, Creed and bless me so that my sincere efforts will become fruitful and successful.
