Direction: Lord Tirumala Sri Venkateswara decided to arrange his "HARINAAMA KSHETRA" near our "Gardenwell" in my native village Chinna Gundavelli, 7 km. away from Sidhipet. He directed me to construct at least the replica of Tirumala Temple upto two compound walls (Silver Doors). He assured me that He will stay here permanently forever in this area by himself and bless the devotees. Also He suggested to arrange Akhanda Harinam Smaran (chanting) by various devotees in shift system with no break. He also informed me to get blessed by Bhagavataas (great devotees) in order to get eligibility to invite Lord from Tirumala besides rigorous practice (Sadhana).

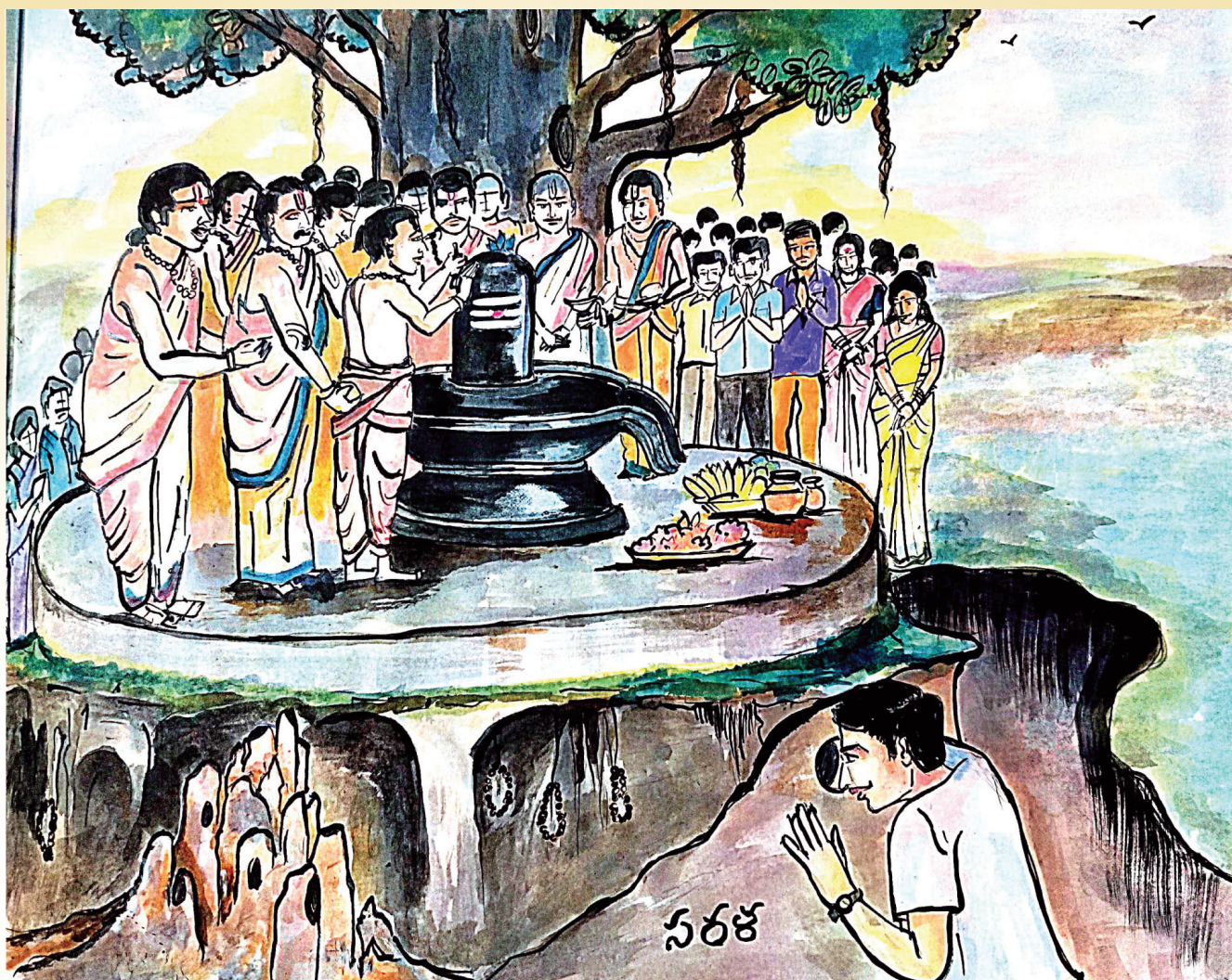
Starting the training from April 2000, thro' my dreams, He disclosed the actual matter in April 2022. In

addition to this, He ordered me to get the divine feelings published which were blessed by him in order to make the devotees as partners in this programme from April 2023. The publishing of present part-17 is its part only (May - 2005).

LAND GRABBING BY HOOLIGANS LAND ISSUE

Land Issue: The aggression of hooligans was increased day-by-day. The Iron rods were embedded twice by them. I filled a case against them. (FIR NO.106/2005, Dt:22.04.2005 & 114/05, Dt:20.04.2005) It made them more envageled. They threatened me stating that they will file SC Act against me with an idea to control this and me and with a bad intention to grab my land, i.e., both of us knocked the doors of Courts without the knowledge of each others. I approached High Court since my land was 1.34 Guntas and they have shown the total width of 4 plots as 1200 yards. We both were given "Status Co-order". As intimated by Lord, these Hooligans came to one understanding for mutual benefit.

Inspite of status Coorder, those hooligans brought JCP forcibly and outragefully put Acid in roots which were previously cut off and made the Uneven land Even so that they will not grow up again. Then I approached police who disappointed me with their



indifferent attitude. While supporting them, they said “will he keep quite if we object him?” No one helped me at that time as they scared that these hooligans may file SC Act against them. As a result, I left out all alone and helpless. The Hooligans occupied my land 3,300 yards approximately, constructed a room and occupied it with no fear at all. Nobody was there to help me except God. While chanting the name of God only, I recollected my dream and thought it was all his divine act; But my fear and excitement were boundless. I was in tension also.

I felt bad for getting cheated and prayed Lord from the bottom of my heart. Filing a case for 1200 yards only for 6 plots, they occupied 3300 yards. I was not allowed to go there. Finally they filed a case against me (FIR No.114/05, dt:30.4.05). Though God

responded me, I failed to understand it. In fact, I didn’t follow his divine acts when I was in property dispute or when I got annoyed.

At that time, He used to answer me analytically. I failed to understand most of his divine acts. Even I couldn’t follow them when I read my complete book of his Divine Acts in 2021. Finally I understood when I wrote this part only.

Having Darshan of Lord with enthusiasm

It was as under:

Dream on 07.05.2005:

I visited a temple to have the darshan of Lord where I found nearly twenty priests approximately who were adoring specially. In other words, special worship



was going on and a number of devotees also attended the same. Even some priests visited particularly to perform this Adoration. Vedic hymns were being read. I, with an aim to see Lord, started shouting ‘O’ Lord! ‘O’ Lord! “My anxiety was uncontrollable and at that time holy bath programme to Lord was going on”. All this Adoration was going on under a Banyan tree. Lord was seated on a seat. The Adoration was going on there only. Seeing me shouting loudly – ‘O’ Lord, ‘O’ Lord, every one gave me way to go nearer to God. Then Lord appeared but not in the form of Lord Sree Venkateswara but in Lord Shiva. I found a Shiva Linga of 1½’ feet height in black colour. I got disappointed and asked him why you appeared like this. Finally, I saluted him since both are some. Later, I found a big ditch thinking that my Lord is there, I got down into it. I noticed a hole on the wall thro’ which when I looked, I saw Lord Sree Venkateswara in that Ant-hill. But I found there Kasi garlands, threads and garlands of Rudraksha. I was told that these priests come here once in a year and worship God. I was just observing Lord thro’ that hole. I saw Lord Sree Venkateswara in small size in black complexion. Lord had shown this divine act which can be understood only when I think deeply. In this, Lord Sree Venkateswara appeared as Shiva outside. It means, the problem what I experienced was though painful, but it will be joyful in the days to come as expected by Lord.

I chanted the name of Lord every minute daily after this incident. I thought to compromise with those who grabbed my land since I don’t have enough capacity or power to fight with them. One of my relatives, who observed my pitiable condition assured me that He will arrange an Agreement through one of his known persons. He belonged to Kadapa district and close to the then Executive Board. I met him in a hotel at Panjagutta explained my land issue who inturn assured

me that he will settle the matter; But I decided firmly to not to think about both land issue and business since I was very busy with my Gruhapravesham function and 7 crores of Japa dedication for 3rd time to Lord Sree Venkateswara.

“GRUHAPRAVESHAM” IN NEW HOME BLESSED BY LORD SREE VENKATESWARA

Date:02.06.2005:

We celebrated Gruhapravesham (Entering function of New home) today i.e. Thursday. I prayed Lord ‘O’ God! Bless me to serve you to the best of my ability and to your utmost satisfaction in this home. We celebrated this function all alone in hurry though some construction works left out as there were no auspicious days. We were there for three days. Every day we conducted paaraayanam. After two months, on 07.8.2005, when we started Chariot procession for offering 7 crores of Japa books third time, we thought that we can do this New home entering function grandly in the midst of all relations and friends. Even we constructed a separate shed for chariot in this same house. Also we purchased a DCM Lorry exclusively for this chariot and got it fixed permanently.

RULES FOR CHARIOT PROCESSION

We conducted 3rd Japa offering at Tirupathi on 27.08.2005. I then planned the places where I can take this chariot ‘Namo Venkatesaaya’. Though it appeared as if it was done by me but entire programme was organized as ordered by Lord Sree Venkateswara. At the beginning of every chariot procession, I have to conduct it according to my first thought that appears in my mind. Otherwise Lord cannot keep quite. An incident took place to ascertain this statement.

The Divine Actions of Sree Venkateswara were awesome and incredible also. One has to analyze them properly. Only then we can understand and enjoy. Such an incident took place in my life.

The fortune of that devotee, to whom God says – “Come, I will allow you to stay in my Room” is beyond words. Nothing we can find any greatness if we read this Leela (Divine Act) casually, but nothing more is required to a devotee if he reads it with devotion. It was as under:

We, this time, planned to take out the procession of Chariot via Kurnool, Ananthapur and Kadapa etc. six places from Hyderabad to Tirupathi. The Mediator, who came to solve my Land issue from Kadapa, requested us to visit Kadapa positively. Also assured for providing us Lodging and Boarding facilities; But we asked them to provide us only place to sleep and meals. Though I was happy to visit Kadapa, Later, I hesitated to visit Kadapa. Having Noticed this, Lord taught us a good lesson, which cannot be forgotten.

We have framed some Rules in connection with our every chariot procession. They were as under:

1. The places to be visited will be decided as per my first thought, that appear in my mind.
2. We have to get prepared even to stay on footpath only in that area if we won't get accommodation. If somebody provides, we have to think that it is nothing but blessings of Lord.
3. We have to take food only at the residences of Devotees to the extent possible and we have to pray God to bless them.

Our meals should be very ordinary. We used to make the people also to pray God. By touching feet of Lord, after offering, Leaf, Flower, Fruit and water. Also we used to make them to write the Mahaamantra of Lord Sree Venkateswara and dedicate. We never expected cash or kind from people but when they willingly offer along with 'KRATU' (book) we used to take and spend for day to day expenses. When we receive any offering (Mudupu) we used to take it and deliver to Lord at Tirumala. We followed these Rules

and traveled to Tirumala but now, I thought of visiting Kadapa first but somehow I changed my mind for following reason. The Divine Act for this was as under:

LORD SAID TO ME THAT HE WILL PROVIDE ACCOMMODATION IN HIS ROOM

Lord Sree Venkateswara blessed me with a “few pure (original) pearls” in my life. It is one of such “pearls”. How and to which we can compare the fortune of such a devotee to whom God himself talked and invited him to come to his room where he will be provided accommodation”? It was happened really in my life. I used to recollect this throughout my life.

Dream on 14.07.2005: In this dream, it so happened that Ex. E.O. TTD Sriman Ajay Kallam called me over phone whom I saw clearly staying at my residence. He was at his home and talking to me. His wife, standing by his side asked him to whom he was talking. EO replied “I am talking to Mr. Sai Reddy”. E.O. asked me – “What Mr. Sai Reddy! Is your chariot not going to Kadapa this time?”

I replied – “I can't say Sir! I doubt whether I get a room there or not”. He felt bad for this and said sarcastically – “Can I get if I come?” Then I said – “Sir! You are great also you are an elderly person. I think you get accommodation there definitely”. He said – “Ok, then come to my room. We both will share it”. That's all. There the dream ended, but it hurt me because Lord spoke to me sarcastically. I felt bad thinking that Swami felt bad because of me. My Chariot procession was not aimed at my personal benefit. I thought that I should not expect any kind of pleasure. On the other hand, this word of Lord blessed me with Joy. When Lord himself invites me to share his Room, then who is fortunate more than me? So, I decided to leave for Kadapa. I wished to see his Divine Act. As such, let us know how Lord provided me place in his Room when we visit Kadapa on 24.08.2005.



STARTING CHARIOT PROCESSION NAMO VENKATESAAYA ON THE OCCASION OF 3RD JAPA OFFERING

Date:02.06.2005: As there were no auspicious days, we celebrated our “Home entrance Function” (Gruha Pravesham) all alone. We invited our relatives and friends to chariot procession which will be started on 07.08.2005 from this same home. Also Sri Sri Sri Ramachandra Jeeyar Swamiji visited our home as we invited him. The Inaugural function of seven crores Japa and Chariot procession was held in direct supervision and with Mangalasaasanams of Sri Swamiji very colorfully. Ex-EO TTD, the then Minister Devender Goud, MLA Sri Lakshman etc., visited. Bhajans, Annamayya Kirthans, Pravachanams were conducted. On the whole, the programme went on well.

I prayed Lord Sree Venkateswara again and again who is very very close to me and invited him to our Gruhapravesham and accept our hospitality since many days. Recently, I thought that Lord told me that Sri Sri Sri Ramachandra Jeeyar Swamiji will appear in dream on his behalf. But I requested Lord again and again to appear in my dream by himself. So I believed strongly that Lord will bless me definitely. Also I waited for a long time for Lord in that procession but invain. With this, I felt bad. One way I felt as if Lord got separated from me. With this, I got fever, but on the same day, during night I dreamt as under:

Dream on 08.08.2005: I viewed Lord Sree Venkateswara in this dream exactly as Lord of Tirumala with auspicious mark mixed with yellow camphor and in between ‘KASTURI’ (Musk) was glittering. That all. I couldn’t follow the meaning of this dream at that time. I thought it is an indication that he is observing me; but I didn’t satisfy with this. On the whole, I got hurt that Lord got separated from me. I was sad. It was resembling the pain when we get at the time of



missing a very close person to our function it was inexplicable; but I followed the real meaning of this dream as under when I was writing this part. I viewed “111” TIRUNAAMAM (Auspicious mark on forehead). He said that “he will definitely come when I offer 111 crores of Japa and put Bottu (An Auspicious mark on forehead). It was the actual feeling. Viewing Lord’s Auspicious mark on forehead.

FIVE SACRAMENTS (Panchasamskarams)

As decided, the next day Sri Sri Sri Jeeyar Swamiji got prepared for performing five sacraments (Samskaaras). All arrangements were made. Swamiji came out of his Room I too got prepared. Meanwhile my wife came and raised objection. So.... I couldn’t accept them.

After few days, on another accession also when I decided to go for five sacraments I, due to some

reasons failed to do so. At that time situations used to turn against to me. Observing this, I thought 'SWAMI' didn't like this, I never tried to go for.

I thought that He may direct or guide me thro' his divine acts if I will act as an ignorant person. Another reason for not trying to accept this is if I become knowledgeable person, I may not see his divine acts. Oflate, I am a parasite. I thought that I should not go for those sacraments unless Lord orders me directly. I opined that what is necessity to me to go for it if God himself is in front of me.

OFFERING PLACE BY SWAMI HIMSELF (LORD SREE VENKATESWARA) IN HIS ROOM

Date:07.08.2005: Started Chariot procession on this day after taking to all important areas in Hyderabad, we reached Kadapa on 24.08.2005 via various cities. Arrangements were made in Sree Venkateswara temple at Devuni Kadapa in a befitting manner at 5.00 PM for starting procession. Sri Navaneeswara Reddy the then Board Member, TTD and two more hon'ble MLAs, Sri Chandra Sekhar Reddy etc., inaugurated this programme. Media has covered this very well. Finally we were allotted Rooms to stay there.

When we reached Rooms at 9.30 PM after procession we noticed that those rooms were very dirty. We couldn't stay there. Private Rooms were not available. As a result, we faced very much inconvenience. The servants of Lord who came along with Chariot slept on Footpath. Finally E.O. of that temple asked me to sleep in his office. Immediately, I recollected the Dream of Lord which I got on 14.07.2005 in which Lord told me to share his Room. I at once agreed. After some time E.O. went away forgetting to give the keys of office Room to me. By that time it was 9.30 PM. I was in dilemma. Finally,

I decided to sleep in temple itself. That day Temple Watchman was absent whose torn Mat was found there. I slept on it in the temple I prayed - 'O' Lord! Sree Venkateswara! I am your servant. As an Attendant and watchman, I am sleeping nearer to you". I spent that night there only. I enjoyed a lot with the feeling thro' out night that I am 'His' servant. Next day we left for Tirupathi. Thus, Lord gave me some space in his room and made me happy May be it a small thing to sleep in a temple; But it made me very much pleased that Swami himself called me and told "come! I will provide space in my room to you.

OFFERING 7 CRORES OF 'JAPA' THIRD (3) TIME TO LORD SREE VENKATESWARA

We reached Paadaala Mandapam, Alipiri of Tirupathi on 26.08.2005 in evening time, offered these Japaas and adored him. Also we prayed Lord to bless the desires of all who wrote Japam (Maha Mantra). On this occasion, Lord blessed us with his original form what we see at the time of holy bath. I just gave a holy bath to his Lotus feet. After the adoration, suddenly there was a heavy down pour.

On 27.8.2005, i.e. on Gokulashtami, TTD has decorated the Sree Venkateswara Divya Mahaa Mantra Sthupa in Dairy form very nicely. We, while connecting Sree Venkateswara Mahaa Mantra to 07 crores Japa, conducted Sri Vishnu Sahasranaama stotra Paarayanam followed by Yajnam (fire offering). Sriman A.P.V.V.S. Sharma garu, the then EO TTD paid a visit and attended Purnaahuthi (conclusion programme) and prayed to fulfill the desires of those who wrote Japa. Later, after inaugurating the 7 crores Japa programme for the 4th time, He left for Tirumala.

One more miracle was shown by Lord here. We arranged 7 crores of Japa on a heap of 6'x5' before sthupa and decorated it with flowers. Suddenly I found the Lotus feet of Lord Sree Venkateswara on it in a gigantic form.



I very clearly witnessed both of his feet and the edge of His Dhoti on them. My Joy knew no bounds at that time. Thus He blessed every devotee whoever wrote Japa. Afterwards, we went to Tirumala on 28.8.2005 had darshan and returned back to Hyderabad on 29.8.2005.

As a matter of fact, the Joy what I got during this Chariot procession, I never got it in any kind of service. Firstly, I planned to do chariot procession only for 11 days every year; But second time, after one year, I extended this for 21 days. During this period, My mental condition was totally different than previous condition. I used to loose my temper even for a small mistake. I was with a strong feeling that more devotees should come and serve Lord to the extent possible. Finally, after 21 days, untill I reach Tirupathi, my mental condition used to be variable. In other words, my behavior was different and also with total surrender to

Lord. I used to be with stability in mind that even some one robs my property, I never get bathered. Especially when I was in other places, I used be very Joyful. Ofcourse, I used to get tired a lot financially, mentally and physically. Anyway this procession was nothing but a boon to me.

BLESSING ME WITH A MEDIATOR

After returning from Tirupathi to Hyderabad, I prayed Lord to bless me with a Mediator to solve my Land dispute since the land grabbers were very powerful. Accordingly, 'Lord' Sree Venkateswara assured me to do so as under:

Dream on 30.8.2005: I witnessed a war scene in this dream. Both the parties on either side were prepared to fight with each others and were keeping their weapons ready. Meanwhile a voice I heard from the Sky. "Look! This person will be with you. He is very powerful. During the battle in between Sri Ram and Ravana this person, in the absence of Rama, was able to withstand before Ravana thrown at him a powerful weapon and saved the Army." My dream got ended with this. I understood that Lord is sending me a mediator who will be with me. Also I thought that the Mediator, appeared in dream previously, is same person whom God sent to me now. I got too much tired since I was very busy for 25 days in Chariot procession. As a result, I was unable to distribute Japas; In spite of it, I arranged to get the Japaas distributed in my office in order to avoid the break. Thus, Lord Sree Venkateswara told me my desire thro' a dream. Also He started narrating incident how my mind was during the service of Lord.

NOT CARING THE FATIGUE IN SERVICE OF LORD

Dream 03.9.2005: In this dream, I was trying to take devotees from Hyderabad to Tirupathi in connection with Yajna (Fire offering) and Pooja. I was

physically tired in this effort but often the devotees were enquiring about programme. My office staff Sri Panduranga Rao etc., asked me to take full rest and not to respond even to phone calls of devotees. They told me that they only will speak to them; But it so happened that we received a phone call from very far. Just to satisfy them, I talked to them. They asked me where to come and when to come. I replied. That's all. This was the dream. In other words, Sree Venkateswara shown me the feeling existing in my mind already that I was attending his service without caring fatigue.

SERVICE WITHOUT ANY ADO

I never expected that all should obey or respect me in spite of conducting the service of Lord by myself. I used to think that I too am a servant. Lord has shown me this feeling also in below divine act very impressively:

Dream of 04.09.2005: I have arranged a grand meeting for Lord in this dream. Our idea behind this was to chant the name of Lord Sree Venkateswara. Many a devotee attended Bhajan programme. In those devotees, two devotees were in Traditional dress i.e. Dhothi and hand banians (Alike Marvaadis) who came exclusively for this. It seems I only was organizing this, but I was there alike an ordinary devotee. I never thought that people should treat me as organizer and only my word should be final. That's all. It was dream. Lord Sree Venkateswara told me that I am leading a simple life alike an ordinary devotee.

Lord Sree Venkateswara used to observe my family and dynasty. He used to predict and inform the what will happen in future. Such an incident took place which was as under:

Dream of 08.09.2005: I saw my eldest son Chi. Vedanth in the dream which I witnessed today in wee hours. He got tonsured his head since one of our relations expired. That's all. It was only my dream. I

thought it may be an indication that somebody in my dynasty may die. I just chanted the name of Lord Sree Venkateswara. As I expected on 07.9.2005 a somebody in my dynasty expired.

About Magazine: Previously Lord Sree Venkateswara ordered me to launch a Telugu periodical. Accordingly, we registered it by name "Namo Venkatesaaya". Also, we gave a declaration also, and completed paper work for printing; but we told various reasons for not launching it since we had no interest. Among those, one was after offering Japa of 7 crores 3rd time and after our Gruhapravesham. Finally we said that we do it after "you declare the launching date". In response to this, Lord told previously itself that "launch it immediately". I left no stone unturned for Magazine and collected addresses of writers and a few articles also we kept them ready since we thought that we cannot do it later. Now, offering 7 crores of Japa (small books containing Sree Venkateswara Mahaa Mantra) third time and ceremony of our Gruhapravesham were completed, we forgot the launching issue of Magazine. Lord Sree Venkateswara has not forgotten. In fact, we kept it aside because in addition to monetary loss, we may not do justice to our business. Lord, Sree Venkateswara having noticed this, taught us a lesson made us to loose financially but totally put me out of business. It was happened phase-wise. Finally He made me to go ahead with the inauguration work of Magazine. For that He, first, decided to improve my mental conditional by admitting me in a spiritual Bachelor degree course and train me up alike a monk. He become very rude. That divine act was as under:

ADMITTING ME IN A SPIRITUAL BACHELOR DEGREE

I have studied in Engineering College of Osmania University. At that time I was in college hostel.



Dream on 09.09.2005: I was studying Engineering course even in this dream. I was in hostel along with four five friends. Since exams were approaching, we were all in preparation. Our professor was teaching some important points in our class room. So I went there where I found a picture. Every student including myself were all covered our faces with Burkha. Though the strength of students was full, their faces were covered with BurkhAs. All who covered their faces were not ordinary persons. One among them was Sri Sri Sri Swaroopanandandra Saraswathi, Head of Saradaa peetham, Visakhapatnam. One more person who was with Burkha, when removed it, I found him alike an African or American Black with small spots on face. They are all learning many new things about God. I too am learning with same Teacher along with them. The dream got disturbed.

The meaning of this dream is I am supposed to know more things about God. My class mates shown me Monks of various religions. So..... I also have also to learn things required for a monk. For this he started imparting training to me without my knowledge from now. One way, I was admitted into spiritual Bachelor degree course. I used to think about my service only, while staring at Lord. In this dream, the same feeling was shown to me.

Dream on 10.09.2005: I was busy with Chariot procession and following NAMO VENKATESAAYA chariot from Hyderabad to Tirupathi. We were somewhere in Tirupathi route. I was explaining about this chariot to somebody. I saw this chariot in dream. That's the dream concluded. It means I was attending the service of Lord Sree Venkateswara whole heartedly.

I was blessed with some more Divine Acts by Lord Sree Venkateswara as under:

Dream on 16.09.2005: I dreamt two dreams today. One to me and one to my wife Surekha. To my surprise, I found myself in Traditional dress in my dream but later I found myself joined communists along with my wife. Afterwards, I left for Tirupathi on some urgent in a private bus. There I found a temple where Sri Sri Sri Kanchi Kamakoti Peethadhipathi was seen. He was in Chaaturmasa Dikshaa. I saw an idol of Lord Brahma, the God of creation, on a compound wall with three heads. That's all my draem.

I understood that I have to study spiritual course and have to go to higher classes.

Now, I will tell you about the dream of my wife Surekha. We read Vishnu Sahasranaamam regularly in the front room of our office along with devotees on every Sravana Nakshttram in evening time. We conducted Adoration because it was Sravana Nakshatra on 15.09.2005. I went outside to attend some work. Surekha attended adoration programme. Many Devotees attended and worshipped Lord but unfortunately they forgot to lit the lamp in my interior room before Lord Sree Venkateswara. Though my wife told the office boy, He it seems told her it is not necessary Madam, since we already lit the lamp in main hall near Adoration place. It was happened yesterday, but today's dream is as under:

The Dream: Surekha, it seems, came to office for Adoration. I was litting the Lamp in front of Lord in my room. She it seems questioned me "Why? It is already there near adoration place you know?" – "No, no ... it is only important" I said and lit the Lamp. That's all, my dream got disturbed. Probably it may be an indication to say that Lord has decided me as an important person in the service provided to me or it may be for identifying my errors.

Land Dispute: The misbehaviors and dominations of hooligans were increasing day by day. They understood that I am all alone and started to act illegally though the case was pending in Court. We arranged a court commission previously who visited my land observed every issue. They wrote in their report that this land belongs to Sai Reddy, there are teak trees, using the land for cultivation and no plots are made here. In spite of it, those Anti-social elements arranged fencing, exhibited their board and posed as they are only the owners of land and even arranged feasts also for all. On the other hand, I was trapped by Sree Venkateswara in his illusion (Maaya). Many I time a wished to compromise with them by paying some amount.

But, a change used to take place next moment itself. I didn't compromise with them thinking that why I have to pay illegally to these hooligans and encourage injustice? Above all I had total confidence on Lord that he will protect me from them; But unfortunately those Anti-social elements became more powerful and started treating me as a Insane (Mad fellow). Finally they brought JCP and cut off the Teak trees from rout level. Also they constructed a room in my land, arranged a fencing one Acre approximately and started staying there openly. Likewise my land issue became worst. One fine morning some persons from Kadapa area came and assured me that they will solve the problem.

DELETING BAD FEELING

These Arbitrators used to stay in a hotel in Panjagutta area in Hyderabad. They used to spend very luxurious life. They had every bad habit. They were very hard and fearless. I used to bear their whole expenditure. After knowing about my land completely, they trapped me in their fist. They used to force me for money. They have every bad habit i.e. drinking, eating, prostitution etc. I guessed that they came to



Hyderabad only just to enjoy the life. They were very Joyful but I used to be unhappy and sad. They used to comment sarcastically about me. In a week moment, I went into wrong track and got attracted with their life style. I, on the same day prayed Lord in the evening like this:-

‘O’ Lord Sree Venkateswara! I am leading a pious and simple life without taking food and even water where as those Arbitrators are enjoying a lot and leading a luxurious life”. I while praying started thinking that what is wrong if anyone lives like that. I prayed Lord to answer me. In turn Swami took this feeling seriously and used to wipe out those ill feelings. Even this feeling was also wiped out within 12 hours.

Dream: I was in my village (Not China Gundvelli) There was only one way to go out and by the side of it, there was broad unused and totally abandoned underground well in one acre land approximately. The Natives of that village used to throw the dirt and rubbish in that well. Also there was a katcha road. People used to go by that road daily. I, that day, boosed a lot and slept on the heap of dirt and rubbish.

When I woke up in the morning, I found some Rubbish & Rag pickers who stood around the steps well and were laughing loudly. Pointing out at me, when they were laughing some villagers too gathered and laughed at me. There ended my dream.

Meaning of this dream was, thro’ this ‘He’ indicated me to not to allow Anti-social feelings in my

mind. In case, they come, He indicated that, even the low class people in society also will laugh at you, with this, a feeling that “they are only great” got vanished from my mind.

Land Issue: The Arbitrators who came to protect my property, had a talk to those hooligans, threatened them but invain. They couldn't save my land. They tried to dispose my total land making the amount into three shares (parts). Out of these three, keeping one part (share) with them they wanted to give one share to me and one to those hooligans. For this, I felt bad but I was helpless. Then I prayed Lord and asked him to order me. Lord gave me green signal and told me to accept this compromise Agreement. This divine act is as under:

Dream on 06.10.2005: I went to the hotel room of the Arbitrators at Panjagutta. By that itself, these Arbitrators were sitting along with hooligans and others who came to purchase the Land. I was just listening to Arbitrators, who were telling something to me. That's all. This was the dream.

Finally we made an agreement on 25.10.2005 to dispose the land. In spite of my prayer for land and to save me, he indicated me to follow their suggestion to dispose the land. With this, I worried a lot for loosing my most favorite property which was not protected by the Sree Venkateswara. I thought to acquire the land again. These arbitrators influenced me. I invested the advance money, which I got on disposing land on another plot again suggested by these Arbitrators and as a result, I lost this also.

What I told you so far, is very very brief. As a matter of fact, it pinched me a lot. I got annoyed on Lord Sree Venkateswara a lot. Thinking that I lost my land because of Lord, I noted the below matter in my dairy.

I, at the cost of my property, liked problems in order to enjoy your great divine acts I told specially to protect my property but Lord taking me into his confidence. He cheated me and :-

1) “You do not know that what will happen to you in future but I am aware of it. So... think me only always. I will take care of you”

2) Once He said – “you are not alone. I am just before and behind you.

3) “Go ahead without fear. Don't get scarred”.

4) I imagined as if I kept my land in a Locker near Lord Sree Venkateswara.

5) When we both (Myself and my better half) got afraid, He blessed us with his darshan made us joyful and said don't worry.

6) I felt very sad when iron rods were arranged in my land and my land got illegally occupied. I prayed him to save me. Then He made me young and arranged a dance programme of a young lady to delight me.

7) Lord Sree Venkateswara assured me that he will protect me and my Miyapur plot and save the money from those hooligans what they expected.

Likewise ‘He’ did a lot many a time. Based on these all I, trusted you ‘O’ Lord, you will protect me. But at the end of the day, He failed to keep up his promise and assurance”. Not only just in this land issue, but also I was put into loss right from the day when I established Mahamantra Peetham, financially. In society, those who started their business as builders, have developed. Their position is far better than me; but I, day by day have become very weak by all means. All these days, I kept quite thinking that God will solve my land issue but it is proved that I am in illusion only. Otherwise, I would have compromised by paying some amount to those Anti-social elements. The feeling that Lord Sree Venkateswara was only the reason for this



all, became strong. Though, I cheated none and legally strong, people considered me as a cheat as I have no legal rights and I am an insane and mentally unsound. Even the Arbitrators (Mediators) eating my hard earned money mocked and insulted me. I was ashamed. All these people, when meet each others, say to each others that I only am correct and they are cheating me, but they degrade me in front of others. I used think that why God is behaving like this and enjoying out of my problems?. A strong feeling cropped up in my mind that he doesn't like me because of this only he did not attend my Gruhapravesham function. Moreover, I have disposed this land for very cheaper rate. In addition to this, I have to pay something to the Mediators also. Then I get much more less amount. It has pained me a lot. I Thought that Lord Sree Venkateswara only is the cause for this pitiable situation. I wrote in my diary in some other context as under:

“Lord has created this situation to me deliberately. I will publish my feelings some or other day. Then, on account of this, won't he get blamed that he has not saved me”. I have a strong feeling appeared in my mind that “there is no soft corner for me in the heart of Lord and he doesn't like me”.

I, of course, spending a huge amount every year for Lord. Taking the Nammo Venkatesaaya chariot to every door, I am making the people to chant his name. I, saying that “chanting the name of Lord will provide you everything and your wishes will be fulfilled”, I used to make them to write the name of Lord. All this I have done for my satisfaction and to get relief from my liability towards him. Never I asked to solve my problem for the service rendered on his name. I believed that my services and problems are totally different from each others. I prayed him like an ordinary devotee; But I never linked it with my service. I was sad that no justice was done in my case. I asked myself what reply I can give to those devotees at the time of chariot procession

or during the distribution of Japa booklets, If they ask me that “how Lord will solve our issues when he didn't solve your problem?”.

One more important thing I have to mention here. I got scared many a time during my property disputes. Then I thought – “O Lord! Your real devotee never gets scared when he faces problems or turmoils, but I got scared. I, many a time, felt that I am unfit to introduce myself to others as your devotee. Though I tried a lot to change this attitude, but failed successfully. It was beyond my capacity”. Anyhow, a sort of sulk (Anger) appeared in my mind on 'HIM' since few months.

Lord Sree Venkateswara on observing my mental condition, felt bad and worried also. He had sent my father to preach me. Since I got annoyed, I failed to understand this divine act which was as under:

The Sudhha Panchami of Pushya Masam, was my father's ceremony i.e. date of expiry. I left for my village i.e. native place to perform death Anniversary. Many years rolled away without seeing my late father. I thought of asking Lord to show him. I begged him also. Lord was so kind enough that he has shown my father and made him also to preach and teach me. This is nothing but two birds at one shot” which was as under:

Dream on 24.12.2005:

I saw my residence near a well in a forest in today's dream. I thought might be it my home situated in Chinnagundavally near garden well. I noticed suddenly that some thieves were robbing some vegetables etc from my home. On observing this, I have thrown a stick at them so that it will hit them. Later I came out and observed that my late father in white robe standing there. He was in same “form” which was before 20 years he had before his death. He was gazing at me seriously with sorrowful face. Also I found a dead snake there in two pieces as it got hit with the stick thrown by

me. It was bleeding heavily also. On seeing this scene, I thought. Is this good omen or bad omen? I chanted the name of Lord Sree Venkateswara in dream itself and prayed, 'O' Lord! Please protect me if this is a bad omen". That's all. The dream got disappeared.

The inner meaning of this dream was The heart of Lord Sree Venkateswara broken into pieces because of my behavior. My anger, on account of loosing property, hurt Lord Sree Venkateswara. My father appeared just to tell me that don't behave like that but follow Lord. He also got hurt because of my misbehavior. Along with this, He appeared in my dream as per my wish, but I couldn't understand this at that time.

My Condition: We celebrated Gruhapravesham function (occupying newly constructed home) and constructed a suitable shed for chariot. I got convenient

space in the room of Lord Sree Venkateswara. I viewed the huge (virat) form of Lord. He admitted me in bachelor degree of spirituality. Also He directed me to give up all ill feelings. My father advised me to not to get annoyed on Lord because of loss of property.

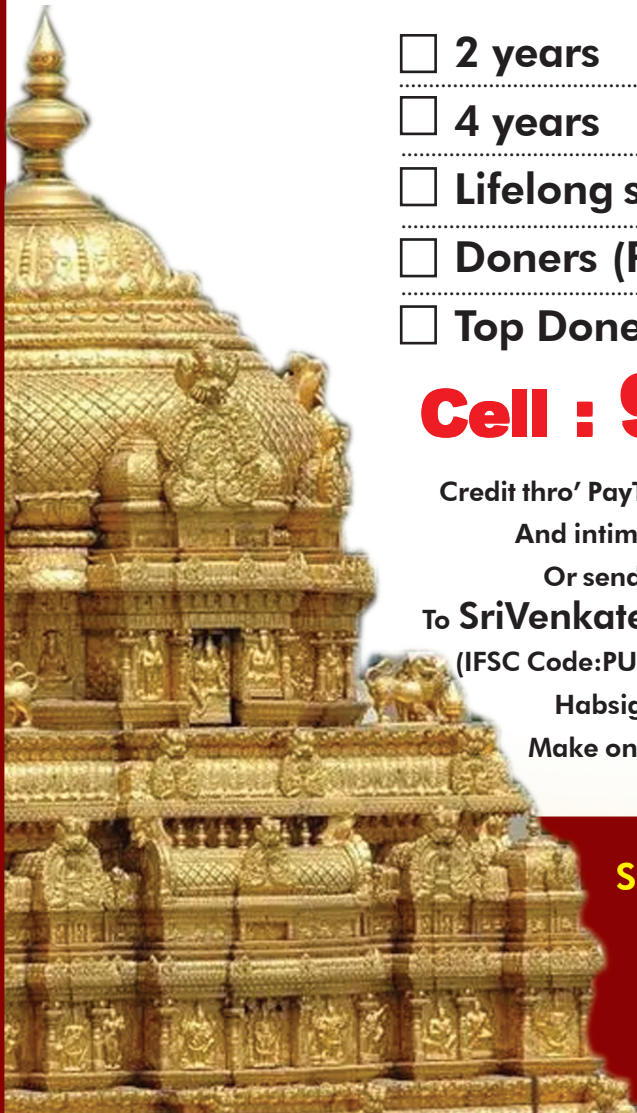
